Distribution of Load Share: *The load will be distributed to eligible vendors as below:*

- i) 50%-L1 vendor**
- ii) 30%- L2 or whoever accepts the counter offer as per ranking.**
- iii) 20%- L3 or whoever accepts the counter offer as per ranking.**

*The load sharing is, however subject to acceptance of **offer (Unit rates) that is to be calculated with reference to percentage allocation given in tender as per above mentioned clause.** The eligible vendors will be asked to match finalized L1 price. In case, any eligible vendor does not accept the counter offer, opportunity will be given to the next ranking vendor.*

In case no other vendor accepts the counter offer of L-1 price the total 100% of the NIT quantity will be given to L-1 bidder. Wherever the numbers of qualified responses (N) are three or more, the distribution shall be limited to (N-1) qualified responses.

Total price quoted against item rate tenders will be considered for evaluation and inter-se ranking. For item rate tenders, it is important that the inter-se ranking as determined at the evaluation stage does not change upon execution of the contract.

To obviate change in ranking, item rate tenders will be invited on the following basis:

(i) Percentage allocation against each item of the BOQ is disclosed in the tender document which becomes the basis for allocation of item wise amount/ rate against the total lump sum price for the entire contracted scope/ BOQ.

Individual item rates so derived based on (ii) above shall be deemed to be the contracted rates for various BOQ items for all purposes.”-AS PER ANNEXURE-B.
